



APPLICATION FOR CITIZENSHIP WASHINGTON FOCUS DELEGATES

Take your 4-H experience to another level through Citizenship Washington Focus (CWF), an eight-day intensive summer citizenship program for youth aged 14-18. Through Citizenship Washington Focus (CWF), teens experience Washington D.C. like never before. Using the nation's capital as their classroom, CWF connects young leaders from across the country to gain the skills and experiences to become effective change agents.

The Johnson County Citizenship Washington Focus program will be a 13-month long program. The next trip will be taken June of 2026. The tentative dates are June 20 - June 27, 2026 (Dates are not announced by National 4-H until December 2025). The cost for each participant will range from \$1,500 to \$2,500, with Johnson County 4-H providing partial funding. Delegates will have opportunities to fundraise and explore other financial assistance methods. **Applications will be accepted for the 2026** trip, now through April 15th, 2025 AT 5pm. All delegates and parents are required to attend an informational meeting about the CWF Program on Thursday, May 8^{th} , 2025, at 6pm at the Extension office.

Johnson County 4-H will take a maximum of 10 delegates. If more than 10 delegates are eligible, those not selected are encouraged to apply for the Kansas 4-H / Oklahoma 4-H trip.
