April 29 & May 1 Deadlines

Adding/Dropping Projects and Enrollment Status

The project add/drop deadline for new and returning 4-H'ers is May 1. 4-H members must be enrolled in the project by May 1 and be approved in 4-H Online to be eligible to exhibit in the corresponding project area at the Johnson County Fair. Project enrollment is an important component of the project experience. 4-H families can update this information any time in 4-H Online by simply clicking the Edit button in the Projects tab within the 4-H member's profile. This option will be available through May 1 and after that the system will not allow any changes to be made to a 4-H member's projects. If you have questions about project enrollment or the May 1 deadline, please contact your club leader or the Johnson County 4-H office.

Horse Identification and Horseless Horse Certificates

All Horse Identification Certificates and Horseless Horse Certificates are **due to the Extension office by 5 p.m. on Friday, April 29** because May 1 falls on a Sunday this year. Appropriate forms can be found at www.johnson.k-state.edu/4-h/events-programs/livestock.html. **Please note that the Horse ID Certificate dated January 2020 must be used. Also posted on the website above is an example of a correctly filled out Horse ID Certificate; it must only be one page (front and back).

4-H Horse Snaffle Bit Project Nominations - Horse snaffle bit project nominations are also **due to the Extension office by 5 p.m. on Friday, April 29** since May 1 falls on a Sunday this year. Along with the nomination, a Horse Identification Certificate and a \$10 fee must be submitted.

Ks Jr Livestock Show & Ks State Fair Livestock Nominations

4-H'ers planning on showing animals at the Kansas Junior Livestock Show (KJLS) and/or the Kansas State Fair must submit nominations to the KSU Youth Livestock office. Market Beef nominations are due by May 1. Commercial Heifer, Swine, Sheep, and Meat Goat nominations are due by June 15.

NEW THIS YEAR: The nomination process is transitioning to an online system for state livestock nominations. Instructions on how to complete the new nomination process are linked on the KSU Youth Livestock Program's website at www.YouthLivestock.ksu.edu under "Nomination Information." Make sure to become familiar with the process right now, as every family will need to plan ahead to make sure all the steps are completed on time and in the correct order.

YQCA Certification Requirement - As a reminder, YQCA certification is required to participate at KJLS and at the Kansas State Fair. See page 8 for more information about YQCA Certification.

Johnson County Ambassador Advisor Position Opening

Johnson County 4-H is seeking an adult volunteer for the Ambassador Advisor position. The Ambassador Advisor facilitates the selection, training and leadership of 4-H Ambassadors and helps to promote 4-H and Extension youth programs in the county. This volunteer role should be a two-year term, might require 4-10 hours of work per month, and requires enthusiasm for 4-H youth, specifically teens. This person must also complete the Johnson County 4-H volunteer screening process. Livestock Ear Tag Information

The entire state of Kansas has been affected by a shortage of livestock eID tags. Johnson County has not been spared. If our tags do not arrive in time for goat, sheep, and swine tagging event dates, we have an alternative plan which has been accepted by the state office. The remaining eID tags we may have, or are receiving from neighboring counties will be given priority to 4-H'ers entering into the Kansas State Fair Grand Drive and/or Kansas Junior Livestock Show. **REMINDER:** Animals must be tagged on or before the date of their corresponding spring show to be able to show in the county fair. Please see page 7 for this year's tagging procedures.

Advice from Mr. 4-H

Question: How has 4-H helped you build your leadership skills?

Mr. 4-H, Ben Burling: When I was seven years old sitting at the 4-H table for the first time, being a part of discussion and voting on pizza for the next club meeting, I had no idea where this thing called 4-H would take me. My experiences in 4-H have helped me in more ways than I can list. The two that stand out the most are: learning and using parliamentary procedures in our meetings and public speaking skills - having the ability to speak to an audience has to be one of the largest assets I have. Every aspect of 4-H has helped me throughout my 4-H journey, the officer positions I have held in

the Morning Glory 4-H Club and in the County Council have helped me grow as an individual and leader. Each 4-H moment helps you build on your leadership skills,

even if you are not thinking of it as leadership, it really is and it's there in your 4-H experiences - from learning to keep order in a meeting, being a committee chairperson, running a station at a day camp, being room monitor at club days, volunteering on a county committee, even helping set up and clean up for your club meetings. My advice to each 4-H'er is keep being a part of your club, lend a hand, put yourself out there for office positions in your club, get involved in county committees, and don't be afraid to try a new project. "If you don't try, there's no opportunity to succeed."

County Fair Entries

4-H entries for exhibits judged during the county fair will be due July 27. All entries for clothing construction, dog show, fashion revue, fiber arts, and home environment will be due on **July 1**. Late entries will not be accepted and if a 4-H'er does not meet the deadline they will not be allowed to have their item or project judged in the 4-H division.

All sheep, swine, beef and goat exhibitors will be required to submit stall requests and tag numbers by July 27. If your family has weighed and tagged their animals under a family nomination, you will be required to enter the tag number(s) with the 4-H member's name who is exhibiting the animal by the July 27 deadline. Livestock exhibitors: you must enter in showmanship if you plan on exhibiting in showmanship.

Only online entries are accepted. The entry system typically opens in early June and is accessible through the Johnson County Fair website at www.jocokansasfair.com. Note: Once an entry is submitted it cannot be edited. If assistance is needed in making online entries please contact the Extension office or the Fair office. It is highly recommended that you print off your entry confirmation. After the entry deadline adding an entry is not an option. If you are not sure about what you are taking to the fair, please wait until closer to the deadline to make your entries. This will help keep dropped entries to a minimum as the Fair Board has to pay for each dropped entry.

All entries including livestock must be accompanied at check-in with a printed entry tag.

Mr. and Miss 4-H

The Johnson County Mr. and Miss 4-H Program recognizes young people for the leadership and commitment they have contributed to the 4-H program and their communities. All 4-H'ers who have been a member for at least three years and are at least 13 (before January 1, 2022) are eligible to apply. More information about the Mr. and Miss 4-H Program can be found at www.johnson.k-state.edu/4-h/events-programs/mr-and-miss-4-h.html. The application will be posted on the website soon and is due July 1. Interviews will be held on a weekday evening in July.

Food and Clothing Labels

Food labels (including those for Food Preservation) are available on the Johnson County 4-H website at www.johnson.k-state.edu/4-h/events-programs/johnson-county-fair.html to print off at home, or they can be picked up at the Extension office.

Clothing labels can be made by printing in ink on a 3" x 5" piece of cloth: Class Number, County, Name, Age and Level. Please refer to your department's rules in the fair book regarding labels.

Departmental Forms

Some departments such as Energy Management, Fashion Revue, and SpaceTech, require additional forms along with the entry. These forms will be posted when available on the Johnson County Fair page on our website at www.johnson.k-state.edu/4-h/events-programs/johnson-county-fair.html. Please refer to each department's rules in the fair book regarding what forms are required.

Photo Mats and Photo Sleeves

The Extension office has photo mats and protective photo sleeves available for purchase. The cost for the pair is \$1.50. Like last year, you will not receive the photo sleeve at the time of purchase as photos will be placed in the photo sleeve by the superintendents during judging. Use a large zip top bag to transport your photos to the fairgrounds for judging. Photos exhibited in the 4-H Photography division at the county fair are required to be mounted on a photo mat. Photo mounting directions and labels can be picked up at the Extension office and they are also posted at www.johnson.ky.johnson-county-fair.html to print at home.

Entering Quilts in the Fair

If you are entering a quilt in the Johnson County Fair the ideal department to enter it in is the Fiber Arts department. The judge for Fiber Arts will be more experienced with quilts and therefore better able to give 4-H'ers helpful feedback.

4-H Foods Judging

The judging for 4-H Foods and Nutrition will take place at Gardner Elementary School from 2-8 p.m. on Monday, August 1. (Participants in the Dog or Horse Shows may come for judging from 12:30-1:30 p.m.)

As you research and test recipes for your food entries, make sure to check out the "4-H Foods Entry Tips for Fair" document posted on Johnson County 4-H website at www.johnson.k-state.edu/4-h/events-programs/johnson-county-fair.html.

Canning and Preservation fair classes: 4-H'ers should only use CLEAR canning jars for the fair. Save the colored blue and green canning jars for home use. Colored jars may have to be opened to check canned ingredients and if it is opened it cannot go on for further judging. This is a food safety issue.

If you have any questions about your food entry, please contact the Extension office.

Project Check-in and Judging

Project check-in will go back to the pre-pandemic schedule of Monday evening (August 1) from 6:30-9 p.m. and Tuesday morning (August 2) from 8-10 a.m. Projects not checked in by 10 a.m. on Tuesday will not be eligible to be exhibited. Plan on arriving before 10 a.m. on Tuesday to have ample time to check in all of your projects. Livestock exhibitors, please refer to the fair book for your check-in time.

The Johnson County 4-H team is working with 4-H superintendents to organize online time slot sign-ups for conference judging, similar to the sign-ups that were used the last couple years. Please stay tuned for more details.

Projects for departments judged before fair have their own judging schedule. Families enrolled in the corresponding projects in 4-H Online will receive information detailing judging for these departments.

Cloverbuds Show and Share

Enrolled Cloverbuds are invited to participate in Show and Share on Tuesday, August 2. This is a reminder that Cloverbuds are not eligible to compete in the 4-H division at the fair. Full membership starts when youth turn 7 before January 1 of the current 4-H year. Cloverbuds are encouraged to show and share 1-2 projects. Sign-ups for time slots will be available at a later date. 4-H Food Stand

The 4-H Food Stand is a great way for youth to help raise funds for Johnson County 4-H Council while practicing safe food handling, interacting with the community and working collaboratively with their club members! Be prepared to work a short shift at the 4-H Food Stand during Fair on your club's assigned day. The funds raised help sponsor county events such as Club Day and Achievement Celebration and provide transportation and scholarships for state events such as Discovery Days and 4-H camp.

Livestock T-shirts

The Johnson County Fair Association requires all livestock exhibitors to wear Johnson County Fair t-shirts when exhibiting livestock at the fair. The fair association is using the same shirt as last year, therefore only 4-H'ers showing for the first time this year or requiring a new size will need to order. The cost is \$10 per shirt. Please send payment and size needed to Allyssa King at 32415 W 95th St, De Soto, KS 66018. Make checks out to Johnson County Fair Assn. Shirt sizes for youth are small, medium and large. Adult sizes are small, medium, large, XL and XXL.

Livestock and Project Auctions

See the 4-H/FFA Livestock Auction section or the 4-H/FFA Project Auction section in the 4-H Fair Book for more details about the Livestock Auction and Project Auction.

Livestock Auction: In order to sell their livestock, exhibitors must turn in auction forms and fill out and sign a W-9 IRS Form by 10 a.m. on Wednesday, August 3.

Project Auction: Project auction entry forms must be turned in by 12 p.m. on Thursday in the Green Building. No late entries will be accepted. An exhibitor selling a project for \$600 or more must complete a W-9 Tax ID (social security) form to the Extension office within 5 days of the auction.

State Fair Entries

4-H exhibits that receive a purple ribbon are eligible to enter at the Kansas State Fair as long as there is a comparable department at the State Fair. To enter in the Kansas State Fair, 4-H members must be 9 before January 1, 2022. 4-H'ers who qualify to exhibit at the State Fair may sign up in the Fair Office from 3-5 p.m. on Thursday, August 4 and Friday, August 5. You may also call or email Christin with your entries. All entries must be into the Extension office by 5 p.m. on Monday, August 8. **Please note:** beef, sheep, swine and meat goat entries for the Kansas State Fair are due by July 15 and Horse Show entries are due by August 1. These projects have a separate entry process.

Project Pick Up

All 4-H livestock and horses can be removed from the fairgrounds after 6 a.m. on Sunday, August 7. All remaining exhibits will be released after the church service which usually concludes around 8:45 a.m. 4-H'ers must pick up their entries or make prior arrangements with another 4-H family to pick up their entries on Sunday morning. If a 4-H'er does not pick up their entries it is the responsibility of the Club Leader to collect the rest of the club's entries.

Premium money will be available for pick up after the fairgrounds have been cleaned. It is expected that all 4-H exhibitors and their families help with fair clean-up. Requested corrections to premium checks must be submitted to the Fair Office by 12 p.m. on Sunday.

Local Opportunities

How Can 4-H Shape Career Pathways

The Johnson County Livestock Program Careers Committee has been working closely with Agriculture Future of America (AFA) to provide 4-H'ers an opportunity for job shadowing in a multitude of careers in agriculture. At the County Council meeting on May 2, the presenter Collin Young from AFA will speak with 4-H'ers about the program and job shadowing opportunities in the KC metro for youth this summer. If you cannot make it to the meeting, the presentation will be recorded and emailed out to all 4-H families. Livestock Mentee and Mentor Grants

Are you a current 4-H livestock project member who could use some additional funding to purchase your animal OR are you a 4-H'er with a desire to participate in a livestock project however unsure of how to afford to purchase an animal or where to start? The Johnson County Livestock Association is providing youth an opportunity to apply for funds to raise 4-H livestock through a Mentee and Mentor Program. Mentee winners will be teamed up with a Mentor winner who will assist in instructing about the project. The Mentee Grant funding can be used for purchases of 2023 livestock projects. The Mentor Grant funding will be paid to the recipient upon completion of the mentorship experience.

The Mentee Grant will be awarded to 4-H members planning to enroll (for the 2023 4-H year) in the following projects and values: \$1,100 to a 4-H'er enrolled in the beef project and \$300 to 4-H'ers enrolled in each of the sheep, swine, and goat projects. Experienced 4-H'ers who apply for the Mentor Grant could earn \$500 for the beef project and \$300 for each of the sheep, swine, and goat projects.

Livestock Project Tagging & Spring Livestock Shows

All market sheep, steers, market heifers, hogs and goats must be tagged by Johnson County Extension staff on or before the respective Spring Show date in order to be eligible to show in the 4-H division at the Johnson County Fair. The cost for the ear tag is \$3 each. Johnson County Extension staff will be on the Johnson County Fairgrounds in conjunction with the Spring Livestock Shows to facilitate the purchasing and tagging process on the following dates:

June 3 (5-7:30 p.m.) — Goats, Sheep, Swine and Bucket Calves only

June 4 (7-9 a.m.) — Goat and Sheep Spring Show participants only

June 5 (7-9 a.m.) — Swine and Bucket Calf Spring Show participants only

County Project Opportunities

YQCA Requirements

What is YQCA? Youth for the Quality Care of Animals (YQCA) is a national, multi-species youth livestock quality assurance program that focuses on food safety, animal wellbeing, and character development, through age-appropriate educational curriculum for ages 7-21. This program is an annual certification that grows with the youth, so the learning modules are different every year.

Who needs to be certified?

<u>Johnson County Fair Exhibitors</u>: All youth age 8 and older exhibiting in the beef, goat, sheep and/ or swine project must be YQCA certified by June 15, 2022 in order to exhibit at the fair. Please remember to print your YQCA certificate to bring to county fair.

<u>Exhibitors at State Livestock Shows</u>: All youth age 7 and older who will be exhibiting market or breeding animals in the Kansas State Fair Grand Drive or Kansas Junior Livestock Show (KJLS) are required to obtain certification. A copy of the YQCA certificate must be included with your nominations.

How do I get certified? Certification can be done by taking a minimum one-hour in-person training or an online training. Both types of trainings are registered for and paid for by going to https://yqcaprogram.org. All registration and payment is handled through the YQCA website and must be done before attending either type of training. The online training is \$12/youth and the in-person training is \$3/youth. (If a family needs financial support, contact the Extension office.) For more information visit www.johnson.k-state.edu/4-h/events-programs/livestock.html. 

Remind Families to Enroll/Re-enroll before the May 1 Deadline!

Please double check with all of the club's families to make sure they are enrolled or re-enrolled by the May 1 deadline. 4-H'ers must be approved in 4-H Online if they plan to participate in the fair. Feel free to contact the Johnson County 4-H office for the most recent list of the club's members. While the portion of 4-H Online for leaders to access is still being worked on, there is a limited amount of information that leaders are able to view at this time. This includes information relating to enrolled members in the club. If you would like to be granted access to the leader portion of 4-H Online and you are currently enrolled, contact Christin.

Project Leaders and Volunteers must be Registered Volunteers

Adults providing supervision to youth at a 4-H program; making decisions on behalf of the 4-H program; having access to private data of 4-H members or volunteers; and/or handling funds as part of 4-H must complete the volunteer screening process, be accepted, and enrolled as a Kansas 4-H volunteer.

Volunteer applications and renewals are completed through 4-H Online. We asked that all returning volunteers complete their renewal by November 1, 2021. If a volunteer has not completed the renewal process in 4-H Online for the 2021-2022 year, they should not be volunteering for your club. Once the renewal process has been completed in 4-H Online and their profile has been approved they may resume their volunteer duties.
